

<b>1</b>	<b>Identification/Appearance</b>
	Roll of cuspated plastic sometimes with textile bonded to one or both sides.  Email: production@abgltd.com Emergency contact: 01484 852992 (08:30-17:00 Monday-Friday)
<b>2</b>	<b>Possible Hazard</b>
	None. No toxic chemicals.
<b>3</b>	<b>Composition</b>
	High Density Polyethylene / Polypropylene.
<b>4</b>	<b>First-aid measures</b>
	For molten or burning material treat as follows: Inhalation: In case of adverse exposure to vapours and/or aerosols formed at elevated temperatures, immediately remove affected person from exposure. Administer artificial respiration if breathing has stopped. Keep at rest. Obtain prompt medical attention.
